Applicants are selected on the basis of scholarship, character, goals and financial need. Applicants are considered for scholarships for which they qualify and the selection committee will interview all finalists.

Submit the **full** application form to the Guidance Counselor of your school. Allow sufficient time for your records to be processed and sent to the Scholarship Board by **February 26, 2010**. Please include a **large envelope with \$1.00 worth of stamps, self-addressed** with your application.

Completed applications (three pages), together with the requested transcript of school records (including mid-year grades), two letters of recommendation, essay (for Public Schools Retirees' scholarship) must be received at the above address by Friday, February 26, 2010. NOTE: Open transcripts will disqualify your application. If applicants have taken the Scholastic Aptitude Test (SAT) or the American College Testing Program (ACT), scores on those tests must be submitted with the transcript.

Available scholarships:

I. Scholarships from the Prince George's County Scholarship Fund:

- A. A to be determined number of scholarships from the General Fund. These scholarships are in the amount of \$500 per year, renewable for four years.

- B. Five scholarships in the amount of \$500, renewable for four years, in memory of Luther Arrington, Carolae Bane, Elaine Damelin, Phillip Malmberg, and Helen V. Page for their dedicated service in promoting academic excellence and the perpetuation of the Prince George's County Scholarship Fund.

II. Other available scholarships for students meeting the following criteria:

- A. Ten Kay Apartment Communities Scholarships in the amount of \$1,000 each. Preference will be given to students graduating from high schools in Prince George's County in Iverson Mall's trading area. Scholarships are based on academic proficiency and good citizenship.

- B. Five Memorial Scholarships of the Prince George's Public School Retirees Association in the amount of \$2,000 will be given to students entering the teaching profession. All applicants must be (a) a high school senior or graduate from a Prince George's County public high school; (b) a higher education student majoring in education; (c) have at least a 3.0 GPA; (d) submit two letters of recommendation, one from a faculty member; and (e) submit a **one-page essay** explaining your intended contribution to the teaching profession.

- C. Four Fraternal Order of Police Scholarships in the amount of \$500 for a student who is the child of an active or retired Prince George's County police officer.

- D. The Jack Willard Scholarship in the amount of \$500 for a student athlete, male or female. Requires a 3.0 GPA, two varsity letters, three years attendance at Prince George's County High Schools, U.S. citizenship.

- E. The Annabelle E. Ferguson Scholarship in the amount of \$500 for a student who has resided in the county for at least two years and shows evidence of leadership and involvement in school programs, activities and organizations. Requires a 3.0 GPA and two letters of recommendation. Preference will be given to students from Bowie, Duval, Fairmont Heights, Forestville, Largo and Suitland High Schools.
